



How Big is a Micron? - A Micron is .000039 of an inch Relative Sizes

- Human eye can see 40 micron (a thousand times smaller than the eye of a needle)
- Diameter of a human hair is about 20 micron
- A *Cryptosporidium parvum* Cyst is 5-15 micron
- E.Coli Bacteria is 0.65 micron wide by 1.7 micron long
 The 3MFF100 does not reduce bacteria
- 3M Purification Inc. filter has pores 0.2 Micron in size
